Feed **PURINATURE LAYENA** as follows:

Feed **PURINATURE LAYENA ABF** free-choice to layers 19 weeks of age or when laying begins. Usually hens will consume between 110 to 130 g/hen/day. Depending on temperature this could range from 120-140 g/hen/day.

For Good Results You Will Need:

- 1. Clean fresh water available for the birds on a free choice basis at all times.
- 2. One tube feeder for every 10 12 hens or 10 cm. of feeder space per hen.
- 3. One nest for every 5 to 7 hens.
- 4. Bedding material to keep the hens warm and clean. Wood shavings, straw and/or sawdust make good bedding materials. The bedding material should be approximately 10 cm deep.
- 5. Supplemental light and ensure that the hens receive 14 to 17 hours of continuous light per day to stay in egg production. If the lights are turned on at 6 a.m. most hens will lay their eggs by 11 a.m.
- 6. Supplement heat during the months. Egg production is substantially reduced when the temperature is less than 15 degrees Celsius. (approximately 60 Fahrenheit)

OPTIMIZE YOUR LAYING RATION

- 1. Provide a source of clean, fresh water at all times.
- 2. Consult your veterinarian for recommended flock health program.
- 3. Directions for use must be followed carefully.
- 4. Do not feed this feed in association with another grain ration, supplement or premix containing selenium.
- Feed is perishable. Store in a dry, well ventilated area protected form rodents and insects. Do not feed mouldy or insect-infested feed to animals or it may cause illness, abortion, or death.
